Application criteria:

- Funding applications are submitted to the ILDP@wrseta.org.za by 31 July 2024.
- Applications are made in accordance with the W&RSETA interventions advertised.
- Applicants are SAQA registered business schools or universities that are able deliver hybrid NQF levels 7 and 8 postgraduate programmes as well as an NQF level 9 aligned, non-accredited programme for 60 senior and executive managers from the Wholesale and Retail Sector.
- Applicants must apply for the entire 60 delegates.
- All learners must be captured on the W&RSETA Learner Management System no later than 28 February 2025.
- All 60 learners registered by the institution on the relevant postgraduate programme in the university or business school's registration system by 17 February 2025.
- Proof of registration submitted to the W&RSETA at ILDP@wrseta.org.za before 17 February 2025.
- Learners Agreements, signed by all parties, must be submitted to ILDP@wrseta.org.za by 14 March 2025.
- Institution must have valid SAQA accreditation/registration and registered with the Department of Higher Education and Training (proof to be attached).
- Institution must be in good standing with the South African Revenue Services must submit a valid Tax Clearance Certificate (proof to be attached).

- Institutions must be registered with the DHET (Proof to be attached to this form).
- Institutions must be registered with the SAQA/CHE (Proof to be attached to this form).
