### The role of this position is to:

- Manage, develop, coach, motivate, performance manage and inspire the Supply Chain Management team ensuring performance against set individual and respective Supply Chain Management service delivery targets
- Ensure adherence to W&RSETA policies, procedures, PFMA and relevant legislation
- Continuously track, monitor and measure Supply Chain Management performance against set standards and performance targets
- Provide formal, standard reporting and feedback ensuring accurate, up-to-date status on Supply Chain performance
- Efficient and effective management, coordination and administration of all BID Committees (Bid Specification Committee, Bid Evaluation Committee and Bid Adjudication Committee)
