- Applications are made in accordance with the W&RSETA intervention advertised and listed in this application template.
- Training provider must have valid SAQA accreditation/registration and must be registered with the Department of Education and Training.
- Applicants are SAQA registered business schools or universities that can deliver online NQF Level 7 management development qualification for 320 middle managers, supervisors and team leaders from the Wholesale and Retail Sector
- Applicants must apply for the entire 320 delegates.
- All learners must be captured on the W&RSETA **Benefit Template** no later than **28 February 2023**
- All 320 learners/delegates are registered by the business school/university on the NQF Level 7 qualification in the institution's registration system by **15 February 2023**.
- Proof of registration submitted to the W&RSETA at RMDP@wrseta.org.za before **28 February 2023**
- Learner Agreements, signed by all parties, must be submitted to RMDP@wrseta.org.za by **28 February 2023**.
- Training Provider must be in good standing with SARS and must submit a valid Tax Clearance.
