Method of application:

- Complete the expression of interest form and select ONE of the above occupational qualifications
- Select ONE of the above occupational qualifications
- Ensure that the TVET principal and contact person's details are completed
- Attach a letter of support from employer willing to partner in the implementation of the programme

Criteria for participation:

- Current extension of scope with the W&RSETA (attach the extension of scope letter)
- Successful implementation of retail programmes (attach reference letters)
- Not currently participating in any W&RSETA infrastructure or equipment support projects for the period 1 April 2021 – 31 March 2022

Successful TVET colleges will be capacitated in relation to the criteria and guidelines for the establishment of retail occupational skills centres which will entail assistance to:

- Acquire SDP accreditation with the QCTO
- Acquire accreditation as an assessment centre with the W&RSETA
- Obtain learning material
- Capacitate lecturers to present occupational programmes
- Infrastructure/equipment support

Submission Requirements:

The closing date for the submission of the expression of interest is Friday, **19 November 2021 at 16:00**. Expressions of interest must be emailed to agoliath@wrseta.org.za with the subject line "Retail Occupational Skills Centres". Any expression of interest not meeting the eligibility criteria will be rendered null and void. Submissions received after the closing date and time will not be considered. Allocations are subject to the sole discretion of the W&RSETA.
