

SUBMISSION OF EXPRESSION OF INTEREST FOR EMERGING SKILLS DEVELOPMENT PROVIDERS

As part of the national transformation agenda, the W&RSETA seeks to form partnerships with new and emerging skills development providers (SDPs) to capacitate them to offer the W&RSETA qualifications. New and emerging skills development providers from historically disadvantaged groups that wish to be supported through a partnership with the W&RSETA are invited to submit an expression of interest. This is a business growth-focused partnership to be entered into with new and emerging historically disadvantaged skills development providers seeking to build sustainable training businesses and to offer W&RSETA occupationally directed qualifications.

The new and emerging SDPs are expected to meet the following criteria:

- Express interest to acquire accreditation for wholesale and retail occupational qualifications through this invitation
- SDP fall within the following HDI categories:
 - Black: African, Indian, Coloured
 - Women
 - Youth
- Be willing to enter into a partnership agreement with the W&RSETA for a period of three (3) years
- Be willing to attend training and development programmes as well as capacitation sessions that are designed to equip the participant with skills to manage a skills development institute
- Willingness to compile and submit portfolios of evidence for any training and development programmes attended to validate competence
- Availability for the W&RSETA to conduct due diligence on existing businesses, and compliance documentation
- Submit progress reports to the W&RSETA at pre-determined intervals

Qualifying Criteria

- New and emerging skills development providers
- Young people with two (2) years' experience in retail or training
- HDI (Black: African, Indian, Coloured and women)
- Persons with Disabilities

Preference will be given to qualifying applicants as follows:

- 60% women and 40% male
- 20% youth
- 5% persons with disabilities (PWD)
- Preference will be given to rural participants

Submission Requirements:

- Allocations are limited to 40 SDPs, and selection will be at the discretion of the W&RSETA.
- The closing date for submission of applications is Friday, **20 August 2021**. Applications received after the closing date will not be considered, and applications that do not meet the application criteria and or eligibility will be disallowed
- Applicants that previously applied for accreditation with the W&RSETA must re-apply
