Application criteria:

- Funding applications are submitted to the ILDP@wrseta.org.za by 31 July 2025
- The institution/university or business school must have a valid SAQA registration credentials and be registered with the Department of Higher Education and Training.
- The institutions must be in good standing with the South African Revenue Services.
- Applicants should submit the application form with relevant supporting documents.
- Applicants must submit a proposal plan with a clear implementation plan
- Applicants must apply for the entire 60 delegates.
- Demonstrate a track record with client references or recommendations of successful implementation of international leadership development programmes with extensive networks for immersions.
- Experience in delivering leadership development programmes in the Wholesale and Retail Sector will be an added advantage.
- All delegates must be registered with the institution by 31 January 2026.
- Registration of all delegates on the W&RSETA Learner Management System by 31 January 2026.
- Failure to meet deliverables within the stipulated timeliness will result in the withdrawal of the allocation and funding will be re-allocated to an institution that is able to meet the timelines.

Application form guidelines:

- This form consists of three sections (A-C), applicants must complete all sections in full .
- Institutions must be registered with the DHET (Proof to be attached to this form).
- Qualifications must be SAQA registered CHE accredited (Proof to be attached to this form).
