CRITERIA FOR SELECTION

CATEGORY A&B

The Training Provider should provide evidence-based proof of the following:

Project Team

- A project team that possesses appropriate qualifications and experience to conduct the training to implement the project successfully
- Certified qualification/s of team members

Methodology and Approach

Roll out plan to indicate:

- The spread of training, allocation of training period, including marking of PoEs and uploading of Assessments
- Examples of tools and instruments including PoE and Assessment formats
- Timelines for specific processes such as remediation, where required
- How they would deal with potential risks (delays and non-submissions from beneficiaries)

Past Experience and References

- Documentary proof of experience of having performed similar work before, through supply of at least 3 reference letters
- Success rate of 90% and above (with proof)

CATEGORY C

The Training Provider should provide evidence-based proof of the following:

- Proof of ownership and registration as a Training Provider in the Disability sector
- Detailed CVs of Lead Training Provider with three (3) or more team members
- Proof of three (3) or more years' experience in Disability training

NOTES:

- 45 beneficiaries have been selected by the W&RSETA and partnership agreements have been concluded.
- The W&RSETA will provide all applicable allowances to the awarded Training Provider, who will disburse these to the 45 beneficiaries.
- The W&RSETA will make all travel and accommodation arrangements for the 45 beneficiaries.
- Applicants are required to provide a costing of the tools of trade in line with the specifications attached as Annexure A of this advert.


