## **W&RSETA Skills Development Providers**

**Subject: Pre-2009 last date of enrolment extension**

### **PURPOSE**

The purpose of this circular is to give clarity and way forward of a DHET Directive on the Implementation and Transitional Arrangements for pre-2009 Qualifications, Gazetted on the 3 June 2024.

### **BACKGROUND**

The W&R SETA has realigned all legacy qualifications into occupational qualifications that are registered by SAQA. W&RSETA, like other SETAs, has written to the QCTO to request a two (2)-year extension for the enrolment end date of all legacy qualifications to ensure the smooth review of our Occupational Qualifications and adjust them to a minimum of 120 credits. Service providers have been contracted for both OQ and EISA reviews. The Department of Higher Education and Training has published in the Gazette the extension of enrolment end dates for legacy qualifications, inadvertently omitting the requested qualifications from W&R SETA.

### **CONCLUSION**

This circular provides provisional extension of all W&R SETA Pre-2009 qualifications Quality Assured Qualifications by two years pending formal discussions between the W&R SETA, QCTO and DHET.
