

RE-ADVERTISEMENT- INVITATION TO SERVE ON THE AUDIT COMMITTEE OF THE WHOLESALE AND RETAIL SECTOR EDUCATION TRAINING AUTHORITY

The Wholesale and Retail Sector Education Training Authority (W&RSETA) invites suitably qualified individuals to serve in the Audit Committee in accordance with section 77 (a) of the Public Finance Management Act, No. 1 of 1999, as amended (PFMA) and Treasury Regulations, as well as the adopted W&RSETA Audit Committee Charter. The W&RSETA seeks to appoint four (4) independent non-Executive Audit Committee Members, including the independent non-Executive Audit Committee Chairperson.

MINIMUM REQUIREMENTS

- A postgraduate qualification in auditing, accounting, risk management, legal, information, and communication technology.
- CIA/CA/MBA/MBL/CISA/CRMA would be an added advantage.
- 10 to 15 years' experience in accounting and auditing, risk management, corporate governance, financial reporting, internal audit process, strategic management, information and communication technology governance, compliance management; and legal knowledge.
- Applicants must have prior experience serving in Audit Committees in the public service environment and demonstrate significant contributions in their practice
- Understanding of the PFMA and its Regulations, GRAP, National Treasury Practice Notes relevant to the entity.
- Knowledge and understanding of the role of Internal and External audits.
- Understanding of the Skills Development legislation and applicable regulatory framework.
- Applicants should demonstrate experience in participating in governance structures and the ability to dedicate time to the activities of the W&RSETA Audit Committee.
- Knowledge and understanding of the SETA environment will be an added advantage.

REMUNERATION

The Remuneration of the members of the Audit Committee shall be in accordance with the National Treasury remuneration guidelines, subject to approval by the Accounting Authority.

TERM OF OFFICE

The tenure of the Audit Committee will be for a period of five (5) years effective from the date of appointment until 1st October 2030.
